BGCWC BEHAVIOR EXPECTATIONS FOR CLUB MEMBERS

Consistent with general behavioral expectations, the following specified behaviors are prohibited on BGCWC property, including Club vehicles, on field trips or any other off-site activity. Each situation will receive individual attention and disciplinary decisions will be made dependent on the severity of the incident. Disciplinary actions are at the discretion of the Unit Director, Director of Operations or CEO.

1. Disruptive, obscene, or disrespectful behavior
2. Foul or abusive language
3. Bullying/Harassment
4. Smoking/Being under the influence of alcohol or drugs/Possession of alcohol or drugs
5. Stealing
6. Willful defiance
7. Fighting/Horseplay
8. Destruction of Property/Vandalism
9. Leaving the site without permission
10. Sexualized behavior
11. Computer misuse
12. Carrying or concealing any weapon of any kind
13. Racial slurs and or discrimination

Disciplinary actions include verbal and/or written warnings; timeouts; alternate programming for the day; conferences with members and/or parents; suspensions and termination from the program.
